This show is sanctioned by the American Dairy Goat Association and ADGA RULES SHALL GOVERN. Only ADGA, AGS and CGS registered, recorded, applied for animals shall be shown. The Combined Junior/Senior Doe show and the Junior Doe show are separately sanctioned.

1. **Mail Entries Early!** Mail Entries to the entry clerk; entries received later than May 15th, 2017 will be considered late and will be charged \$12.00 per doe.
2. **\$8.00 pre-enters your doe in both rings of either the Combined show OR the Junior show. Not Both.** Late and Day-of-show entries will be accepted at \$12.00 per doe. Entry fee must accompany entry form. NO REFUNDS. Substitutions are permitted within breed.
3. The entry clerk will not accept personal checks from any exhibitor whose check from the previous year's show was not honored by their bank. In addition, any entry from such an exhibitor will not be accepted until the previous year's amount due has been paid in full.
 - The base date for computing age is the day of the show - May 20, 2017.
 - The order of the show is not subject to change. Combined Junior/Senior show will precede Junior Show.
 - Only original registrations for animals 6 months of age or older will be accepted. A stamped, duplicate for animals less than 6 months of age is permissible. Papers must be shown to Entry Clerk prior to show start.
 - Health check to be done by appointed committee and their decision is final.
 - Be prompt! All animals should be on the grounds prior to 8:00 AM and between 7:00 AM and 8:30 AM, all exhibitors must be checked in with the Health Inspector and the Entry Clerk.
 - **Show starts promptly at 9 AM! No Showmanship Classes.**
 - **Exhibitors are required to clean up their pens and areas. Exhibitors failing to clean up their pens/areas may be barred from showing at the next year's show. There will be no pen cleaning service available this year.**
 - Parking and camping will be permitted. Electric hook-up charge is \$25.00 if needed.
 - Beverages and food will be available for purchase during the show.
 - Donations and support for the raffle table will be greatly appreciated.
 - **Hay and bedding are not provided and must be furnished by the exhibitors. NO WOOD SHAVINGS ALLOWED!**
 - There will be no tack pens allowed due to lack of pen space.
 - Goats with horns may not be shown.
 - Exhibitors wishing to show their permanent champions are requested to enter them in the Champion Challenge Classes; however, ADGA rules state it is the exhibitor's choice whether to enter in the age or the challenge class.
 - **There will be absolutely no smoking permitted in the barn at any time.**
 - There will be no pre-show milk-out, please exercise common sense and milk out at a reasonable time.
